This meeting is an opportunity for members to share their input and feedback about the Bargaining Goals.

UWOFA will send notice to bargain to the employer hopefully this week. The Negotiating Committee expects to be at the negotiating table at the end of May, early June. The latest edition of the Faculty Times contains a great deal of information about the Librarians

and Archivists. This is important to build understanding and solidarity with both bargaining units. There is a Solidarity Event tomorrow, April 2, at The Wave from 3 to 5 pm.

# **5. Presentation of Negotiation Goals:** *J. Weststar and K. Hoffmann*

J. Weststar and K. Hoffmann reviewed the goals for the 2019 librarian and archivists Negotiations, Exhibit II, appended to agenda.

In addition to the goals presented, the bargaining unit discussed office space, particularly during renovations.

That the following goal be added to the list of Bargaining Goals under Working Conditions: To ensure that individual work space adequately addresses the needs of privacy, professionalism and well-being.

K. Hoffmann explained that this goal gives the Negotiating Committee an opportunity to at least talk with the employer about office space and working conditions.
