Articles of Continuance (import)

4 - Statement of the purpose of the corporation

The purpose of the Association is to promote the professional well-being of its Members, to assist its Members in their professional relations with the University of Western Ontario and to act as bargaining agent on behalf of units of Members that have been certified to be represented by the Association for collective bargaining purposes under the Ontario Labour Relations Act.

The Membership is to consist of individuals only and is to include all Members of bargaining units certified to be represented by the Association. Each Member is entitled to receive notice of, attend and vote at all meetings of Members and is entitled to one vote at such meetings.

7 - Statement regarding the distribution of property remaining on liquidation

Provided the Association is not a soliciting corporation under the Act at the time of dissolution, after the discharge of any liabilities of the Association the property of the Association is to be divided into as many equal shares as there are Memberships in the Association and one share is to be distributed to the holder of each Membership. In the event that the Association is a soliciting corporation under the Act at the time of dissolution, after the discharge of any liabilities of the Association the remaining property is to be distributed to one or more qualified donees as defined under the Income Tax Act (Canada).

8 - Additional provisions, if any

- 1) The Board of Directors may appoint additional Directors for a term expiring not later than the close of the next annual meeting of Members but the total number of Directors appointed may not exceed one-third of the number of Directors elected at the previous annual meeting. The precise number of Directors to be appointed in this manner may be fixed by ordinary resolution of the Members.
- 2) In its operations the Association is not to provide direct financial gain to its Members. Any profits or other accretions of the Association are to be used in promoting its purpose.
